2. Except the students mentioned above, all persons who received Sinovac vaccine, or persons aged 12 years old or above who received BioNTech vaccine, provided they have not been infected with COVID-19: should have received three doses of COVID-19 vaccine; or
3. Students having received two doses of vaccine on or before 1st October, 2022, who are still within the time interval waiting to receive the third dose of vaccine will be regarded as meeting the respective vaccination requirements; or
4. A person who has been infected with COVID-19, who requires one less dose of COVID-19 vaccine than others.
